

2016 Thunderbird Northwest Regional Championship Regatta

Notice of Race

1. **RULES:** The regatta will be governed by the Racing Rules of Sailing, as prescribed by the U.S. Sailing Association, Thunderbird class rules and the Regatta sailing instructions.
2. **ELIGIBILITY AND ENTRY:** The event is open to all Thunderbird class yachts possessing a current measurement certificate. Skippers must be international Thunderbird Class Association members with 2016 dues paid.
3. **FEES:** \$55.00 if payed by August 15th. \$65.00 if payed after August 15th.
4. **SCHEDULE:** Racing will take place September 3rd and 4th, 2016. See schedule of events for further details.
5. **VENUE:** Racing will occur on the waters of Port Townsend Bay, which is along the city front. The race course location may be changed at the discretion of the race committee.
6. **ORGANIZING AUTHORITY:** Port Townsend Fleet 33 and the PTSA are the organizing authorities and Joe Daubenberger is the Regatta Chairman.
7. **MOORAGE:** Space has been reserved at Point Hudson Marina (360-385-2828). Skippers must call the marina and make their own reservation. Explain that you are part of the Thunderbird regatta. Boats may raft as needed.
8. **SAILING INSTRUCTIONS:** will be available at the Saturday morning skipper's meeting (see schedule of events for details).
9. **PRIZES:** will be awarded for the top three finishers.
